## THIS ENDORSEMENT CHANGES THE POLICY.

The parties agree to amend the Policy on the terms contained in this endorsement as follows:

The following change takes effect from 6 November 2014.

### 1. PART IVA CONDITIONS RELATING TO COVER FOR EMPLOYED (DEFINED BENEFIT) MEMBERS IN DIVISION 2, DIVISION 5 AND DIVISION 8 (DB)

1.1. Part IVA of the Policy is amended by adding the following new condition 16D after condition 16C:

#### "16D. SPECIAL OFFER FOR DIVISION 2 MEMBERS

16D1.1. A *Division 2 member* who transfers into *Division 6* is eligible to receive cover under this Policy as described in this condition 16D if he or she satisfies all of the following conditions immediately prior to the date cover commences under condition 16D.1.3:

- a) must be at least 15 years old;
- b) must be an *Australian resident*;
- c) must not have reached the *cover cessation age*; and
- d) be employed by the *principal employer* or be employed by an *associated employer* accepted by *us* under this policy pursuant to condition 15;
- e) be working for a minimum of 15 hours or more per week;
- f) not be employed on a *casual basis*;
- g) submitted an application to *you* to accept the special offer available to *Division 2 members*;
- h) the application described in paragraph g) was dated on or before 31 October 2014;
- i) the application was accepted by *you* prior to 6 November 2014; and
- j) satisfies *our underwriting requirements*.

16D.1.2. Where a *Division 2 member* applies for cover under condition 16D.1.1. and meets all eligibility conditions under condition 16D.1.1, *we*, or *you* on terms approved by *us*, may:

- a) accept or decline that person's request; or
- b) apply exclusions or other special conditions to any cover which is accepted in writing.



16D.1.3. Cover for a member under condition 16D1.1. will begin on the later of:

- a) the date *we* agree in writing to provide cover; and
- b) the date the *member* has sufficient account balance for the payment of applicable premiums with respect to their cover.



16D.1.4 Where *we* accept the person's request under condition 16D.1.2., the amount of cover that comes into effect for that *member* will be *default cover*."

**All other terms and conditions of the Policy remain unchanged.**
